

## MARINA SAILING RULES

ONLY PATRONS LICENSED THROUGH THIS MARINA MAY RESERVE AND OPERATE THE SAILBOAT FOR WHICH THEY ARE LICENSED.

1. No alcohol on boats.
2. All boats are reserved on a first-come first-served basis.
3. Reservations (without a deposit) are taken no earlier than the Thursday prior. Reservations can be made up to 60 days in advance with a deposit of ½ the rental rate. This deposit is NONREFUNDABLE except if the reservations are cancelled prior to the close of business on the Wednesday prior.
4. Reservations are held for 15 minutes only. If a patron is more than 15 minutes late and has not called, they will be considered a NO SHOW. Three NO SHOWS will constitute a 30-day suspension of license.
5. The maximum capacity of the sailboats is as follows:

CAPRI 16.5'	5 PEOPLE	CAPRI 22'	6 PEOPLE
TOPPER	2 KIDS OR 1 ADULT	HARPOONS	4 PEOPLE
AMERICAN 18'	6 PEOPLE		

There is no distinction for age, size or weight.
6. Life jackets required for all those aboard (Capri 22' has on board already).
7. During gale wind warnings, waterspouts, thunderstorm conditions, or any other condition considered unsafe by the Marina manager, boats will not be allowed out.
8. Follow all directions given by the Marina staff.
9. Never rig a boat pointed down wind.
10. Smoking is not allowed while you are raising, rigging or handling sails.
11. The mooring area is restricted to leaving or approaching the Marina and not for recreational sailing.
12. All sailboats must obey the 500-yd buffer zone off the flight line. An imaginary line drawn from the end of the fuel pier to the "B" mark "prohibited area" buoy, then continue the imaginary line to prohibited area marker "A," this defines the off-limits zone. You must not sail between the line and the base shoreline. The Navy SAR area and all reefs and shorelines are off limits as well.
13. All reef and shorelines around Coconut Island are OFF LIMITS. No fishing, no snorkeling, and no going ashore. This is a state marine refuge.
14. The patron is responsible for righting any capsized rental boat without Marina assistance.
15. Skipper is responsible for all actions and safety of his/her crew/guests. Any discussion with Marina staff concerning vessel operation will be conducted with the skipper ONLY.

16. A patron renting a boat in variable wind conditions will be responsible for returning the boat ON TIME. Lack of wind is no excuse.
17. The patron must be back at the pier by their designated return time. A 15-minute grace period will be granted. Any patron more than 15 minutes overdue will be towed in and charged a \$20 rescue/late fee.
18. Running into a moored vessel or any stationary object is prohibited.
19. All incidents and damage must be reported to the Marina staff immediately upon return to the pier. The sails will be folded, then the sails and other equipment will be returned to the Marina counter attendant. Sails that got wet must be rinsed and dried. Any damages not noted when the boat was checked out becomes the responsibility of the patron who signed for the boat.
20. The sandbar is off limits during kona (southerly) wind conditions.
21. Do not beach the boats at the sandbar. You must always anchor.
22. NEVER DOCK A BOAT GOING DOWN WIND.
23. Any obvious display of lack of seamanship which could endanger property, life or limb may result in automatic suspension or loss of license, i.e.
  - a. Running aground
  - b. Failure to report an incident or damage
  - c. Operating in excessively shallow waters or dangerously close to reef (within 10 ft)
  - d. Inability to maneuver to or from the Marina without assistance
  - e. Uncontrolled sailing maneuvers that endanger captain or crew (such as unintentional GYBE)
  - f. Losing halyards
  - g. Blatant unsafe or abusive operation
24. Violation of the aforementioned rules and procedures may result in suspension of sailing license or loss of sailing license.
